1.1 Disclaimer

1.3 Structure of the RFP

This RFP document issued by the **Nodal Authority – Mission Director, National Health Mission, Uttar Pradesh** for the Selection of Eligible Authorized Service Agency in Diagnostic Radiology approved by AERB as Consultants, comprises of the following.

- 1.3.1 Instructions on the Bid process for the purpose of responding to this RFP. This broadly covers:
 - a) General instructions to Bidders for bidding process (Section 1.5)
 - b) Bid evaluation process including the parameters for Bid Qualification, Technical responsiveness evaluation and financial evaluation to facilitate Nodal Authority in determining bidder's suitability as the Consultant (Section 1.6)
 - c) Bidder's appointment process (Section 1.7)
 - d) Payment Terms (Section 1.9)
 - e) Bid submission document formats (Appendix A, B, C, D, E, F, G & H)
- 1.3.2 Delivery Requirements of the project. The contents of the document broadly cover the following areas:
 - a) About the project and its objectives (Section 1.4)
 - b) Scope of work for the Consultant (Section 1.8)
 - c) Service requirements for the Consultant (Section 1.8)

The bidder is expected to respond to the requirements as completely and in as much relevant detail as possible, and focus on demonstrating bidder's suitability to become Consultant to the Nodal Authority.

Note: A Draft Contract Agreement has been provided separately in **Part II – Draft Contract Agreement**

The bidders are expected to examine all Instructions, Forms, Terms, Project requirements and other information in the RFP documents. Failure to furnish all information required as mentioned in the RFP documents or submission of a bid not substantially responsive to the RFP documents in every respect will be at the Bidder's risk and may result in rejection of the bid.

1.4 Background Information

1.4.1 Basic Information

- a) Nodal Authority, **Mission Director, National Health Mission, Uttar Pradesh** invites responses ("Bids") to this RFP from Bidders ("Consultants") who are from the List of Authorized Service Agency approved by AERB for:
- Compliance Study for Radiation Safety Compliance of the existing Facilities where Radiology/Radiation Emitting Equipment are installed as per the locations mentioned in Schedule A.
- Infrastructure Development of those Radiology/Radiation Emitting Equipment at the Facilities which are Non-Compliant to meet all statutory Safety Regulations of AERB.
- Issuance of "License for Operation" from AERB of all the Radiology/Radiation Emitting Equipment installed at the Facilities of all the clusters.

Details are further described under **Sections 1.8** of this RFP document.

- b) Any contract that may result from this bidding process will be issued for a **period of 1 (one) year** ("the Term").
- c) Bids must be received not later than time, date and at the venue mentioned in the Bid Data Sheet. Bids that are received late **WILL NOT** be considered in this procurement process.

1.4.2 Project Background

Diagnostics Radiology has been the key diagnostic tools for many diseases and has an important role in monitoring treatment. It is a statutory requirement to have radiation safety in all the diagnostics radiology facilities which have radiology/ radiation emitting equipment installed. These facilities should be in compliance with regulations specified under the Atomic Energy (Radiation Protection) Rules, 2014.

This Project is envisioned to get the real situational analysis of the level of Compliance and Infrastructure conditions of all the State Public Health facilities which have radiology/radiation emitting equipment installed as per the AERB Compliance norms and to obtain "License for Operation" from AERB.

1.4.3 About the Nodal Authority – National Health Mission

NHM, National Health Mission launched in 2005 as NRHM (National Rural Health Mission) has six financing components:

- a) NRHM-RCH Flexipool,
- b) NUHM Flexipool,
- c) Flexible pool for Communicable disease,
- d) Flexible pool for non-communicable disease including injury and trauma,
- e) Infrastructure Maintenance and
- f) Family Welfare Central Sector component.

Within the broad national parameters and priorities, states have the flexibility to plan and implement state specific action plans. The state PIP includes the key strategies, activities undertaken, budgetary requirements and key health outputs and outcomes.

The State PIPs are an aggregate of the district/city health action plans, and include activities to be carried out at the state level. The state PIP also includes all the individual district/city plans. This has several advantages: first - it will strengthen local planning at the district/city level, second - it would ensure approval of adequate resources for high priority district action plans, and third - enable communication of approvals to the districts at the same time as the state.

The State PIP is approved by the Union Secretary of Health & Family Welfare, based on appraisal by the National Programme Coordination Committee (NPCC), which is chaired by the Mission Director and includes representatives of the state, technical and programme divisions of the MoHFW, national technical assistance agencies providing support to the respective states, other departments of the MoHFW and other Ministries as appropriate.

1.5 Instructions to the Bidders

1.5.1 **General Instructions**

- 1.5.1.1 The bidder should prepare and submit its offer as per instructions given under this **Section** 1.5.
- 1.5.1.2 The bids shall be submitted along with hard copies of all documents. Those submitted by fax or by email with attachments shall not be considered.
- 1.5.1.3 The bids which are for only a portion of the components of the job /service shall not be accepted (the bids should be for all components of the job /service).
- 1.5.1.4 The price quoted shall be firm and shall be quoted in the format as per attached **Appendix 'F'** only.
- 1.5.1.5 The bids (comprising of Technical and Financial) shall be submitted (with a Forwarding Letter as per **Appendix 'E'**) before the last date of submission. Late bids shall not be considered.

- 1.5.1.6 While every effort has been made to provide comprehensive and accurate background information, requirements and specifications, Bidders must form their own conclusions about the services needed to meet the requirements. Bidders and recipients of this RFP may wish to consult their own legal advisers in relation to this RFP.
- 1.5.1.7 All information supplied by Bidders may be treated as contractually binding on the Bidders, on successful award of the assignment by the Nodal Authority on the basis of this RFP.
- 1.5.1.8 No commitment of any kind, contractual or otherwise shall exist unless and until a formal written contract has been executed by or on behalf of the Nodal Authority. Any notification of preferred bidder status by the Nodal Authority shall not give rise to any enforceable rights by the Bidder. The Nodal Authority may cancel this public procurement at any time prior to a formal written contract being executed by or on behalf of the Nodal Authority.
- 1.5.1.9 This RFP and its contents supersedes and replaces any previous public documentation & communications on this RFP and its process, and Bidders should place no reliance on such communications.
- 1.5.1.10 Right to Terminate the Process
- 1.5.1.10.1 Nodal Authority may terminate the RFP process at any time and without assigning any reason. Nodal Authority makes no commitments, express or implied, that this process will result in a business transaction with anyone.
- 1.5.1.10.2 This RFP does not constitute an offer by Nodal Authority. The bidder's participation in this process may result in selection of the bidder by the Nodal Authority towards execution of the contract.

1.5.2 Compliant Bids / Completeness of Response

- 1.5.2.1 Bidders are advised to study all Instructions, Forms, Terms, Requirements and other information in the RFP documents carefully. Submission of the bid shall be deemed to have been done after careful study and examination of the RFP document with full understanding of its implications.
- 1.5.2.2 Failure to comply with the requirements of Section 1.5.2 may render the bid non-compliant and the bid may be rejected. Bidders must:
- 1.5.2.2.1 Include all documentation specified in this RFP;
- 1.5.2.2.2 Follow the format of this RFP and respond to each element in the order and form as set out in this RFP

1.5.2.2.3 Comply with all requirements as set out within this RFP.

1.5.3 Key Requirements of the Bid

1.5.3.1 RFP Document Fees

- 1.5.3.1.1 This RFP document can be downloaded from http://upnrhm.gov.in
- 1.5.3.1.2 Cost of RFP / Bid Enquiry document will be a non-refundable fee of Rs. 15,000/- (Rupees Fifteen Thousand Only), even if a bidder opts to apply for more than one cluster. The bidder will submit non-refundable fee of Rs 15,000 (Rupees Fifteen Thousand only) in the form of account payee Demand Draft, drawn on a scheduled bank in India, in favour of State Health Society, Uttar Pradesh payable at Lucknow. The demand draft of RFP document fees should be submitted along with bids.

1.5.3.2 Earnest Money Deposit (EMD)

- 1.5.3.2.1 Bidders shall submit, along with their Bids, EMD of following amount(s) based on the cluster they shall be bidding for. EMD should be in the form of a Fixed Deposit or Bank Guarantee (in the format specified in (Appendix E) issued by any Nationalized/Scheduled Indian bank in favour of State Health Society, Uttar Pradesh.
 - Cluster 1: Rs. 1.85 Lakhs
 - Cluster 2: Rs. 2.45 Lakhs
 - Cluster 3: Rs. 2.23 Lakhs
 - Cluster 4: Rs. 1.67 Lakhs
 - Cluster 5: Rs. 2.48 Lakhs

If a bidder opts to bid for more than one cluster, the bidder will need to furnish as EMD an amount equal to the arithmetic sum of EMD for each cluster that the bidder intends to bid for.

- 1.5.3.2.2 It may be noted that no bidding entity is exempt from deposit of EMD along with its bid. Bids submitted by bidders without EMD shall be rejected.
- 1.5.3.2.3 The EMD of unsuccessful bidder will be returned to them without any interest, within 30 days after the signing of agreement with the successful bidder.
- 1.5.3.2.4 The EMD of the successful bidder will be returned without any interest, after receipt of its Performance Security as per the terms of the Contract.

1.5.3.2.5 EMD of a bidder may be forfeited without prejudice to other rights of the Nodal Authority, if the bidder withdraws or amends its bid or impairs or derogates from the bid in any respect within the period of validity of its bid (Bid Validity Period indicated in Section 1.5.4.10) or if it comes to notice that the information /documents furnished in its bid is incorrect, false, misleading or forged. In addition to the aforesaid grounds, the Successful Bidders' EMD will also be forfeited without prejudice to other rights of Nodal Authority, if it fails to furnish the required Performance Security within the specified period or fails to sign the contract in accordance with this RFP.

1.5.3.3 Submission of Bids

The bids shall be made in TWO (2) SEPARATE SEALED ENVELOPES as follows:

- 1.5.3.3.1 The two separate envelopes containing both Technical Bid (sealed) and the Financial Bid (sealed) shall be together put in a bigger envelope, which shall be sealed again and superscripted with SPMU/NHM/Procure/AERB/2016-17/30
- 1.5.3.3.2 The **First Envelope** shall be marked in bold letter as "**TECHNICAL BID**" which shall be sent along with Forwarding Letter ("**Appendix C**") and shall include the following:
- 1.5.3.3.2.1 Bid Cost Payment Receipt: Demand Draft towards the cost of bid document to be attached in case bid document has been downloaded from website http://upnrhm.gov.in.
- 1.5.3.3.2.2 Fixed Deposit / Bank Guarantee towards **EMD**.
- 1.5.3.3.2.3 Confirmation regarding furnishing **Performance Security** in case of award of contract.
- 1.5.3.3.2.4 Original bid document duly stamped and signed in each page along with the Forwarding Letter confirming performing the assignment as per "Appendix C".
- 1.5.3.3.2.5 Particulars of the bidder as per "Appendix B".
- 1.5.3.3.2.6 Copy of the certificate of registration from AERB as Authorized Service Agency in Diagnostic Radiology which should remain valid till the term of the Contract.
- 1.5.3.3.2.7 Copy of the Income Tax Returns Acknowledgement for last three (3) Financial Years.
- 1.5.3.3.2.8 Copy of Audited Accounts Statement for the last three (3) Financial Years.
- 1.5.3.3.2.9 Copy of the certificate of registration of CST, VAT, EPF, ESI and Service Tax with the appropriate Authority valid as on date of submission of bid documents.

- 1.5.3.3.2.10 A duly notarized declaration from the bidder in the format given in the "Appendix H" to the effect that the firm has neither been declared as defaulter or black-listed by any Competent Authority of Government of India or Government of any State.
- 1.5.3.3.2.11 List of clusters that the bidder intends to bid for as per proforma given in "Appendix G".

In addition to the above documents,

- 1.5.3.3.3 The **Second Envelope** shall contain the financial bid and shall be marked in bold letters as "**FINANCIAL BID**". The price quoted shall be firm and shall be quoted in the format as per attached **Appendix D** only.
- 1.5.3.3.4 The bidder's bid shall contain no interlineations or overwriting except as necessary to correct errors, in which cases such correction must be initialed by the person or persons signing the bid.
- 1.5.3.3.5 In case of discrepancy in the quoted prices, the price written in words will be taken as final and valid.
- 1.5.3.3.6 Please note that Prices should not be indicated in the Technical Bid but should only be indicated in the Financial Bid.
- 1.5.3.3.7 The outer (larger) envelope thus prepared should also indicate clearly the name, address, telephone number, E-mail ID and fax number of the bidder to enable the Bid to be returned unopened in case it is declared "Late".
- 1.5.3.3.8 All the pages of the bid must be sequentially numbered and must contain the list of contents with page numbers. Any deficiency in the documentation may result in the rejection of the Bid.
- 1.5.3.3.9 The original bid shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except as necessary to correct errors made by the bidder itself. Any such corrections must be initialed by the person (or persons) who sign(s) the bid(s).
- 1.5.3.3.10 Cover page and Cover Letter of the bid shall be initialed and stamped by the person or persons who sign the bid.

1.5.3.4 Bid Preparation Costs

The bidder shall be responsible for all costs incurred in connection with participation in the RFP process, including, but not limited to, costs incurred in conduct of informative and other diligence activities, participation in meetings/discussions/presentations, preparation of bid, in providing any additional information required by Nodal Authority to facilitate the evaluation process, and in negotiating a definitive contract or all such activities related to the bid process.

Nodal Authority will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

1.5.3.5 Language

The Bid should be filled by the Bidder in English language only. If any supporting documents submitted are in any language other than English, translation of the same in English language is to be duly attested by the Bidders. For purposes of interpretation of the bid documents / responses, the English translation shall govern.

1.5.3.6 Late Bids

- a. Bids received after the due date and the specified time (including the extended period if any) for any reason whatsoever, shall not be entertained and shall be returned unopened.
- b. The bids submitted by telex/telegram/fax/e-mail etc. shall not be considered. No correspondence will be entertained on this matter.
- c. Nodal Authority shall not be responsible for any postal delay or non-receipt/ non-delivery of the documents. No further correspondence on the subject will be entertained.
- d. Nodal Authority reserves the right to modify and amend any of the above-stipulated condition/criterion depending upon project priorities vis-à-vis urgent commitments.

1.5.4 Evaluation Process

- 1.5.4.1 Nodal Authority will constitute a Bid Evaluation Committee to evaluate the responses of the bidders.
- 1.5.4.2 The bids will be scrutinized by the Bid Evaluation Committee to determine whether they are complete and meet the essential and important requirements, conditions set out by this RFP and whether the bidder is eligible and qualified as per criteria laid down in the Bid Enquiry Documents. The bids, which do not meet the aforesaid requirements and/or do not provide requisite supporting documents / documentary evidence required to meet eligibility criteria are liable to be treated as non-responsive and may be ignored or rejected.
- 1.5.4.3 The decision of the Nodal Authority as to whether the bidder is eligible and qualified, and whether the bid is responsive, shall be final and binding on the bidders. No correspondence will be entertained outside the process of negotiation/ discussion with the Selection Committee.
- 1.5.4.4 The Evaluation shall only be carried out Cluster wise.
- 1.5.4.5 Financial bids of only those bidders, who qualify on technical qualification criteria, will be considered and opened.

- 1.5.4.6 The Bid Evaluation Committee may co-opt representatives of one or more relevant Departments Agencies/Entities as may be deemed necessary.
- 1.5.4.7 The Bid Evaluation Committee may ask for meetings with the Bidders to seek clarifications on their bids.
- 1.5.4.8 The Bid Evaluation Committee reserves the right to reject any or all bids on the basis of any deviations.

1.5.4.9 Bid Opening

- 1.5.4.9.1 The Bids submitted up to on or before stipulated date and time, as indicated in Bid Data Sheet S. No. 7, will be opened at **19-A, Vidhan Sabha Marg, Om Kailash Tower, Lucknow** as per date and time indicated in Bid Data Sheet S.No. 8, by Selection Committee and/or Nodal Authority or any other Officer(s) authorized by Nodal Authority, in the presence of such of those Bidders or their representatives who may be present at the time of opening.
- 1.5.4.9.2 The representatives of the bidders should be advised to carry the identity card or a letter of authority from their respective bidding firms to identify their bonafides for attending the opening of the bids.

1.5.4.10 Bid Validity

The bids shall remain valid for acceptance for 180 days from the date of opening of bids and the Contract will be valid for duration of 1 (One) Year. The contract may be extended for another term of 01 (One) Year based on review of performance and with mutual consent.

1.5.4.11 **Bid Scrutiny**

- 1.5.4.11.1 Initial Bid scrutiny will be held and incomplete details as given below will be treated as non-responsive. If Bids
 - a) Are not submitted in as specified in the RFP Document.
 - b) Received without the Affidavit as per Appendix F
 - c) Are found with suppression of details.
 - d) With incomplete information, subjective, conditional offers and partial offers submitted.
 - e) Submitted without the documents requested, as set out **under Section 1.5.**
 - f) Have non-compliance with any of the clauses stipulated in the RFP.
 - g) With lesser validity period.

1.5.4.11.2 All responsive Bids will be considered for further processing as below: Nodal Authority will prepare a list of responsive bidders, who comply with all the Terms and Conditions of this bid. All eligible bids will be considered for further evaluation by a Selection Committee according to the Evaluation process defined in this RFP document.

The decision of this Committee will be final in this regard.

- 1.5.4.11.3 **Evaluation for Eligibility:** The bids will be evaluated for Eligibility to bid based on documents submitted. The following documents will be examined:
- 1.5.4.11.3.1 Bid Document Cost and EMD (Appendix E) Non submission of these documents will lead to summary rejection of the bid and the bid will not be evaluated further.
- 1.5.4.11.3.2 Submission of Eligibility Documents with respect of Technical Eligibility requirement i.e.

 Copy of the certificate of registration from AERB as Authorized Service Agency in

 Diagnostic Radiology
- 1.5.4.11.3.3 Submission of cumulative Turnover requirements documents.
- 1.5.4.11.3.4 Non submission of Technical Eligibility documents and Turnover documents will lead to the rejection of the bids.

1.5.4.12 Infirmity / Non-Conformity

The Nodal Authority may waive minor infirmity and/or non-conformity in a bid, provided it does not constitute any material deviation. The decision of the Nodal Authority as to whether the deviation is material or not, shall be final and binding on the bidders.

1.5.4.13 Bid Clarification

Wherever necessary, the Nodal Authority may, at its discretion, seek clarification from the Bidders seeking response by a specified date. If no response is received by this date, the Nodal Authority shall evaluate the offer as per available information.

1.6 Criteria for Evaluation

1.6.1 Technical Qualification Criteria

- 1.6.1.1 The bidder should be registered with AERB as Authorized Service Agency in Diagnostic Radiology.
- 1.6.1.2 Minimum average turnover of the bidder during last three financial years, for each bid, has to be as indicated below:
 - Cluster 1: Rs. 1.85 Crore
 - Cluster 2: Rs. 2.45 Crore

- Cluster 3: Rs. 2.23 Crore
- Cluster 4: Rs. 1.67 Crore
- Cluster 5: Rs. 2.48 Crore
- 1.6.1.2.1 If a bidder opts to bid for more than one cluster, then its turnover must be more than or equal to the arithmetic sum of the average turnover required for the corresponding clusters.
- 1.6.1.3 Government-owned enterprises or institutions shall be eligible only if they can establish that they (i) are legally and financially autonomous, (ii) operate under commercial law, and (iii) that they are not dependent agencies of the Nodal Authority.
 - To establish eligibility, the government-owned enterprise or institution should provide all relevant documents (including its charter) sufficient to demonstrate that it is a legal entity separate from the government; it does not currently receive any substantial subsidies or budget support.
- 1.6.1.4 Government Officials and Civil Servants of any Central/State Government are not eligible to be included as Experts in the Consultant's Proposal.
- 1.6.1.5 The Bidders are not presently blacklisted by the Nodal Authority or by any State Govt. or its organizations by Govt. of India or its organizations (Appendix F).
- 1.6.1.6 The bidder shall declare all ongoing litigations it is involved in with any Government Agency/ State/Central department (Appendix F).

1.6.2 Technically Responsive Bid(s)

All bids meeting the criteria set out in **Section 1.6.1** shall be considered as Technically Responsive and eligible for Financial Bid opening.

1.6.3 Financial Bid Evaluation

- 1.6.3.1 The Financial Bids of technically qualified/responsive bidders will be opened on the prescribed date in the presence of bidder representatives.
- 1.6.3.2 The Financial bid evaluation will be based on the relevant stated Bid parameters. Any conditional bid, deviating from the bid conditions, will be rejected.
- 1.6.3.3 The bidder offering the Lowest Evaluated Total Price (Cost of Compliance Study and Infrastructure Development along with all the applicable taxes) for each Facility as per the bid parameter will be the selected L-1 bidder and shall be called for further process leading to the award of the Contract.

1.6.3.3.1 Errors & Rectification: Arithmetical errors will be rectified on the following basis: "If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail".

1.7 Appointment of the Successful Bidder as Consultant

1.7.1 Award Criteria

Nodal Authority will award the Contract to the successful bidder whose bid has been determined to be technically responsive and having the least cost Financial Bid as per the process outlined in this RFP.

1.7.2 Right to Accept Any Bid and to Reject Any or All Bid(s)

Nodal Authority reserves the right to accept or reject any bid(s), and to annul the bidding process / Public procurement process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for Nodal Authority action.

1.7.3 Notification of Award

- 1.7.3.1 The Nodal Authority shall issue the Notice for Award or Letter of Intent/Award of the Contract to the successful bidder within the Bid Validity Period.
- 1.7.3.2 The successful bidder will be required to sign and submit the contract (Part II Draft Contract Agreement) unconditionally within 21 days of receipt of such communication.
- 1.7.3.3 The Letter of Award (LOA / LOI) will be issued by Mission Director, National Health Mission, Uttar Pradesh.
- 1.7.3.4 In case the bidding process / public procurement process has not been completed within the stipulated period, Nodal Authority, may like to request the bidders to extend the validity period of the bid.
- 1.7.3.5 The notification of award will constitute the formation of the Contract. Upon the successful bidder's furnishing of Performance Security, Nodal Authority will notify each unsuccessful bidder and return their EMD.

1.7.4 Modification to Contract

The Contract when executed by both the parties shall constitute the entire Contract between the parties in connection with the jobs / services and shall be binding upon the parties. Modification, if any, to the contract shall be in writing and with the consent of both the parties.

1.7.5 **Performance Security**

- 1.7.5.1 The successful bidder shall furnish a Performance Security in the shape of a FDR/Bank Guarantee issued by a Nationalized Bank/Scheduled Indian Bank in favour of State Health Society, Uttar Pradesh for an amount as specified in the Bid Data Sheet's S. No. 13. The Bank Guarantee shall be as per proforma at "Appendix E" and will remain in force up to and including 180 (One Hundred and Eighty) days after the period of contract validity. This shall be submitted within 21 days of receiving of Notice for Award of Contract, failing which the EMD may be forfeited and the Contract may be cancelled.
- 1.7.5.2 If the selected Bidder / Consultant violates any of the terms and conditions of contract, the Performance Security shall be liable for forfeiture, wholly or partly, as decided by the Nodal Authority and the contract may also be cancelled.
- 1.7.5.3 The Nodal Authority will release the Performance Security without any interest to the selected Bidder / Consultant on successful completion of Contractual term and/or its obligations.

1.7.6 **Signing of Contract**

- 1.7.6.1 After the Nodal Authority notifies the successful bidder that its bid response has been accepted, Nodal Authority shall enter into a contract, incorporating all clauses, pre-bid clarifications and the bid of the bidder between Nodal Authority and the successful bidder.
- 1.7.6.2 The Draft Legal Contact Agreement is provided as a separate document, and has been attached herewith this RFP bid document. (Part II Draft Contract Agreement)
- 1.7.6.3 The individual Contracts will be signed between Director General Medical and Health, Department of Medical Health & Family Welfare, Government of Uttar Pradesh and the Successful Bidder(s).
- 1.7.6.4 The Implementing, Monitoring Authority and Payment Authority will be Director General Medical and Health, Department of Medical Health & Family Welfare, Government of Uttar Pradesh.
- 1.7.7 Failure to Agree with the Terms and Conditions of the RFP and its Contract Agreement

- 1.7.7.1 Failure of the successful bidder to agree with the Draft Legal Agreement and Terms & Conditions of the RFP shall constitute sufficient grounds for the annulment of the award, in which event Nodal Authority may award the contract to the next technically responsive and most economical bidder (having next best least cost) or call for new bids from the interested bidders.
- 1.7.7.2 In such a case, the Nodal Authority shall invoke the Performance Security of the next most technically responsive and least cost bidder.

1.7.8 Compliance of Minimum Wages Act and other Statutory Requirements

The Consultant shall comply with all the provisions of Minimum Wages Act and other applicable labor laws, applicable AERB Safety Code & Safety Manual. The Consultant shall also comply with all other statutory provision including but not limited to provisions regarding medical education and eligibility criteria of human resources used for providing the services, radiation safety, occupational and environmental safety.

Legal liability to the extent of reporting of Compliance Study and Infrastructure Development for each facility/cluster extends to the Consultant.

The Consultant shall maintain confidentiality of the information shared by Nodal Authority for facilitating the Contract and all the records, information which is generated as an end deliverable of this Contract.

1.7.9 Income Tax Deduction at Source

Income tax deduction at source shall be made at the prescribed rates from the Consultant's invoices / bills. The deducted amount will be reflected in the requisite Form, which will be issued at the end of the financial year.

1.8 Scope of Work

1.8.1 General Project Overview

The Mission Director, National Health Mission has planned to conduct a compliance study across the state for AERB Safety Regulations. The mapping of the facilities where Radiology/Radiation emitting Equipment are installed in public health facilities will provide quantitative and qualitative data for radiation safety compliance. Further to compliance mapping study the selected agency is expected to upgrade the infrastructure of the installation to meet all statutory regulations of AERB including but not limited to TLD Badges, lead Aprons, documentation formats, civil work, warning light etc.

1.8.2 Work Description

The obligations of the Consultant under this service contract shall include following service activities and commitments. The details of locations are given in **Appendix 'A'**.

Should a situation arise, wherein the Authority may require to conduct AERB compliance study and infrastructure upgradation work, alongside acquisition of License of Operation, for additional facilities, the Consultant may be required to provide their expertise and services over for the same (within a Cluster or across Clusters). However, in such a case, the Consultant will be given a prior intimation and based upon a mutual agreement, the Consultant will be paid additionally per the payment terms of this RFP and its Contract.

1.8.2.1 Compliance Study,

The Consultant will conduct the safety regulations survey across all facilities in scope of study. The study will identify gaps from the AERB Regulations [Atomic Energy (Radiation Protection) Rules, 2004]:

- 1.8.2.1.1 Data Collection in the prescribed format (refer Appendix H) for all the facilities in scope of study.
- 1.8.2.1.2 Submission of Survey Report and Work plan for Infrastructure Development.
- 1.8.2.1.3 Enlist the infrastructure augmentation requirement.
- 1.8.2.1.4 Describe the implementation guidelines for infrastructure augmentation.
- 1.8.2.1.5 Submit a list of installed Radiology/Radiation emitting Equipment which are not type approved to the authority.

1.8.2.2 Infrastructure Development

Based on the findings of Compliance study's gap analysis, the Consultant shall upgrade the non-compliant facility as per AERB Regulations [Atomic Energy (Radiation Protection) Rules, 2004], and which shall require the following tasks to be performed

- 1.8.2.2.1 Ensure Availability of patient (1 no.) and Healthcare worker (2 nos.) Lead Apron gown.
- 1.8.2.2.2 Installation of Warning Lights.
- 1.8.2.2.3 Lead Lining for Doors as per AERB Regulations.
- 1.8.2.2.4 Protective (Mobile) Barriers with Viewing Glass for Healthcare Workers.
- 1.8.2.2.5 Availability of Chest Stand (1 no.).
- 1.8.2.2.6 Civil Work like closure of Windows, Shifting of Entrance Door, Increase in wall thickness as per AERB Regulations.
- 1.8.2.2.7 Proper Display of Radiation Hazard Signage.
- 1.8.2.2.8 Conduct Quality Assurance and Calibration of all equipment.
- 1.8.2.2.9 Procurement/Purchase of all required items for Infrastructure upgrade, and their replacement or repair in case of defects after installation, shall be the responsibility of the Consultant

1.8.2.3 Issuance of "License for Operation" by AERB

After ensuring compliance and upgradation of the facilities (as need be), the Consultant shall facilitate issuance of "License for Operation" from AERB for the equipment and all the relevant facilities mentioned in Appendix A. For obtaining License of each facility, the Consultant needs to enter facility details in e-LORA (e-Licensing of Radiation Applications) Website.

The following are the steps for obtaining License through e-LORA for each facility:

- 1.8.2.3.1 Step 1- Registration of Facility with e-LORA.
- 1.8.2.3.2 Step 2- Declaration of X-ray Equipment details with e-LORA.
- 1.8.2.3.3 Step 3- "License for Operation" of Existing X-ray Equipment in e-LORA.
- 1.8.2.3.3.1 Step 3.1- Availability of Qualified Radiation Workers (TLD cards should be available).
- 1.8.2.3.3.2 Step 3.2- Availability of required Safety Tools.
- 1.8.2.3.3.3 Step 3.3- Layout and Shielding Details (as per AERB requirements).
- 1.8.2.3.3.4 Step 3.4- Quality Assurance Test Report.
- 1.8.2.3.3.5 Step 3.5- Approved RSO
- 1.8.2.4 The Consultant shall hand over of all the documents/reports/findings/presentations/collated data prepared as per the scope of this project to the Nodal Authority at the termination or end of the Contract.

1.8.2.5 Time Frame for Completion of Services and Liquidated Damages:

The overall duration for completion of services for each cluster can be categorized across three phases which would be considered from the day of signing of the Contract by the Authority and the Selected Bidder.

- 1.8.2.5.1 Phase 1: Completion of Compliance Study of all the facilities in a Cluster within 60 days from the day of signing of the contract by both parties.
- 1.8.2.5.2 Phase 2: Completion of Infrastructure Development of those Radiology/Radiation Emitting Equipment at the Facilities which are Non-Compliant to meet all statutory Safety Regulations of AERB within 180 days from the day of signing of the contract by both parties.
- 1.8.2.5.3 Phase 3: Issuance of License of Operation from AERB for all the Radiology/Radiation Emitting Equipment at facilities in a Cluster within 365 days from the day of signing of the contract by both parties.

1.8.2.6 **Liquidated Damages:**

- 1.8.2.6.1 The Liquidated Damage for non-commencement of services for each phase will be applicable at the rates on per day basis for each cluster as mentioned below,
 - Cluster 1: Rs. 18.52 Thousand
 - Cluster 2: Rs. 24.54 Thousand
 - Cluster 3: Rs. 22.31 Thousand
 - Cluster 4: Rs. 16.73 Thousand
 - Cluster 5: Rs. 24.76 Thousand
- 1.8.2.6.2 The Liquidated Damage will be recoverable from the Performance Security, and up to a maximum of 5% of the signed contract value (Maximum Value). Upon reaching the Maximum Value, this contract will be terminated as per termination procedure.

1.8.2.7 **Penalty Charges:**

- 1.8.2.7.1 For delay up to 15 days in completion of services in each phase, a penalty of 0.5 % of Contract Value of a Cluster shall be levied on the Consultant.
- 1.8.2.7.2 For delay between 16-30 days in completion of services in each Phase, a penalty of 1 % of Contract Value of a Cluster will be levied on the Consultant.
- 1.8.2.7.3 For delay of more than 30 days in completion of services in each Phase, the Contract shall be terminated with forfeiture of Performance Security.

1.9 Payment Terms

- 1.9.1 The Director General Medical and Health, Department of Medical Health & Family Welfare, Government of Uttar Pradesh will be the Paying Authority.
- 1.9.2 The Payment will be linked to the following delivery milestones for a Cluster,

- 1.9.3 The Nodal Authority shall form an Inspection Committee which will perform the Final Inspection of the work done by the Consultant as part of Scope of Work mentioned in Section 1.8. The Inspection Committee shall include Government Officials, Diagnostic Radiology Professionals and/or relevant Medical Industry Experts.
- 1.9.4 The Consultant shall submit an invoice of the Civil Work (Layout) done for the Radiology/ Radiation Emitting Equipment installed in the facilities in a Cluster as per the applicable PwD Rates to the Paying Authority on the monthly basis. The UP-PwD Rate List can be referred from the website (http://uppwd.up.nic.in/pdf/42%20PAGES.A.pdf).
- 1.9.5 The Consultant shall submit a Self-Declaration to the Paying Authority, comprising of relevant proofs (where applicable) of work done for AERB compliance at that facility, for completion of each milestone, which shall form the basis for the payment model defined in Clause 1.9.2.
- 1.9.5.1 The Consultant will submit the invoice/Self-Declaration Form on monthly basis to the Paying Authority.
- 1.9.5.2 The Paying Authority can raise objection within 15 days of receipt of invoice/Self-Declaration Form and on 16th day the verification claim will be considered approved; in case no objection is raised.
- 1.9.5.3 In case of objection raised by Paying Authority, the same will be resolved through verification from the Inspection Committee formed by the Nodal Authority.
- 1.9.5.4 After verification of invoices/Self-Declaration Form, the Paying Authority will make the payment within 30 days of verification of the Invoices or after 30 days of resolution of dispute, whichever is later, for all invoices/Self-Declaration Form raised.
- 1.9.5.5 The payment will be subject to all Statutory Taxes, Tax Deducted at Source (TDS), as per Applicable taxes and laws.
- 1.9.6 The Consultant hereby acknowledges and agrees that it is not entitled to any revision of the Payment Terms or other relief from the Paying Authority except in accordance with the express provisions of this Agreement.
- 1.9.7 Penalties would apply on payments, as defined in this RFP document, due to nonconformance to the Service and Operations & Maintenance Requirements

1.10 Other Terms and Conditions of the RFP and Contract

1.10.1 Downstream Work

The Nodal Authority does not guarantee, support or state any the possibility of any downstream work arising of this contract. Downstream work and its procurement/bidding process strictly follows the Government of India defined Conflict of Interest clauses.

1.10.2 Fraud and Corrupt Practices

- 1.10.2.1 The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Selection Process. Notwithstanding anything to the contrary contained in this RFP, the Nodal Authority shall reject a bid without being liable in any manner whatsoever to the Bidder, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices") in the Selection Process. In such an event, the Nodal Authority shall, without prejudice to its any other rights or remedies, forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Nodal Authority for, inter alia, time, cost and effort of the Authority, in regard to the RFP, including consideration and evaluation of such bidder's bid.
- 1.10.2.2 Without prejudice to the rights of the Nodal Authority under Clause above and the rights and remedies which the Nodal Authority may have under the LOI or the Agreement, if a Bidder, as the case may be, is found by the Nodal Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Selection Process, or after the issue of the LOI or the execution of the Agreement, such Bidder or Consultant shall not be eligible to participate in any Bid or RFP issued by the Nodal Authority during a period of 2 (two) years from the date such Bidder, as the case may be, is found by the Nodal Authority to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.
- 1.10.2.2.1 For the purposes of this Section, the following terms shall have the meaning hereinafter respectively assigned to them:

- 1.10.2.2.1.1 "corrupt practice" means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of any person connected with the Selection Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Nodal Authority who is or has been associated in any manner, directly or indirectly with the Selection Process or the LOI or has dealt with matters concerning the Agreement or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Nodal Authority, shall be deemed to constitute influencing the actions of a person connected with the Selection Process); or (ii) save as provided herein, engaging in any manner whatsoever, whether during the Selection Process or after the issue of the LOA or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Agreement, who at any time has been or is a legal, financial or technical Consultant/ adviser of the Nodal Authority in relation to any matter concerning the Project;
- 1.10.2.2.1.2 "fraudulent practice" means a misrepresentation or omission of facts or disclosure of incomplete facts, in order to influence the Selection Process;
- 1.10.2.2.1.3 "coercive practice" means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person's participation or action in the Selection Process;
- 1.10.2.2.1.4 "undesirable practice" means (i) establishing contact with any person connected with or employed or engaged by Nodal Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or (ii) having a Conflict of Interest; and
- 1.10.2.2.1.5 "restrictive practice" means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Selection Process.

1.11 Conflict of Interest

1.11.1 A bidder shall not have a conflict of interest that may affect the Selection Process or the Solution delivery (the "Conflict of Interest"). Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Nodal Authority shall forfeit and appropriate the EMD, if available, as mutually agreed genuine pre-estimated compensation and damages payable to the Nodal Authority for, inter alia, the time, cost and effort of the Nodal Authority including consideration of such Bidder's bid, without prejudice to any other right or remedy that may be available to the Nodal Authority hereunder or otherwise.

1.11.2 The Nodal Authority requires that the Consultant provides solutions which at all times hold the Nodal Authority's interests' paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The Consultant shall not accept or engage in any assignment that would be in conflict with its prior or current obligations to other clients, or that may place it in a position of not being able to carry out the assignment in the best interests of the Nodal Authority.

1.12 Damages for Mishap/Injury

The Nodal Authority shall not be responsible for damages of any kind or for any mishap/injury/accident caused to any personnel/property of the Consultant while performing duty. All liabilities, legal or monetary, arising in that eventuality shall be borne by the Consultant.

1.13 Termination of Contract

- 1.13.1 The Nodal Authority may terminate the contract under following circumstances: If the successful bidder withdraws its bid after its acceptance or fails to submit the required Performance Securities for the initial contract and or fails to fulfill any other contractual obligations. In that event, the Nodal Authority will have the right to purchase the services from next eligible bidder and the extra expenditure on this account shall be recoverable from the defaulter. The Earnest Money and the Performance Security deposited by the defaulter shall also be recovered to pay the balance amount of extra expenditure incurred by the Nodal Authority.
- 1.13.1.1 The following conditions will be treated as failure to fulfill the key contractual obligation:
- 1.13.1.1.1 Criminal Indictment and excess and/or forged billing to the Nodal Authority/ Paying Authority
- 1.13.1.1.2 Insolvency
- 1.13.1.1.3 For delay of more than 30 days in completion of services in each Phase (as defined in Clause 1.8.2.5).
- 1.13.1.1.4 Failure to commence the services even after reaching the maximum Liquidated Damages which is equal to the Performance Security amount.
- 1.13.2 The Consultant will be served a notice of termination by the Nodal Authority and will be required to make corrections within 30 days failing which the services will be treated as Terminated.

1.13.3 In that event, the Nodal Authority will have the right to purchase the services from next eligible bidder and the extra expenditure on this account shall be recoverable from the defaulter. The earnest money and the performance security deposited by the defaulter shall also be recovered to pay the balance amount of extra expenditure incurred by the Nodal Authority.

1.13.4 Arbitration

- 1.13.4.1 If dispute or difference of any kind shall arise between the Nodal Authority and the Consultant in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual consultations.
- 1.13.4.2 If the parties fail to resolve their dispute or difference by such mutual consultations within thirty days of commencement of consultations, then either the Nodal Authority or the Consultant may give notice to the other party of its intention to commence arbitration, as hereinafter provided. The applicable arbitration procedure will be as per the Arbitration and Conciliation Act, 1996 of India and the rules there under. Any statutory modification thereof for the time being in force shall be deemed to apply to the arbitration proceedings under this clause. Arbitral Tribunal shall consist of three Arbitrators. Each Party shall appoint one Arbitrator and both Arbitrator shall appoint Presiding Arbitrator. If the arbitrator to whom the matter is initially referred is transferred or vacates his office or is unable to act for any reason, he / she shall be replaced by another person, appointed by the party appointing the outgoing Arbitrator, to act as the new Arbitrator. Such person shall be entitled to proceed with the matter from the stage at which it was left by his predecessor. The Arbitrator shall give reasoned award in case the amount of claim in reference exceeds Rupees 1 Lakh (Rs.1,00,000/-)
- 1.13.4.3 Work under the contract, notwithstanding the existence of any such dispute or difference, shall continue during arbitration proceedings and no payment due or payable by the Nodal Authority shall be withheld on account of such proceedings unless such payments are the direct subject of the arbitration.
- 1.13.4.4 Reference to arbitration shall be a condition precedent to any other action at law.
- 1.13.4.5 Venue of Arbitration: The venue of arbitration shall be Lucknow.

1.13.5 Applicable Law and Jurisdiction of Court

The contract shall be governed by and interpreted in accordance with the laws of India for the time being in force. The Court located at Lucknow shall have jurisdiction to decide any dispute arising out of in respect of the contract. It is specifically agreed that no other Court shall have jurisdiction in the matter.
