## **National Mobile Medical Unit (NMMU): Project Background**

National Health Mission (NHM), Uttar Pradesh intends to operationalize 150 Mobile Medical Units (MMUs) under the National Mobile Medical Unit (NMMU) project for 30 Districts in Uttar Pradesh. The objective of NMMU project is to provide Primary Health Care Services--Preventive, Promotive, Curative, Diagnostic and Referral Health Services to the un-served/underserved areas of the state with focus on JE/AES affected and High Priority districts.

## **Stakeholder Consultation held on 2<sup>nd</sup> Feb, 2015 at UP Sadan, Chanakyapuri, New Delhi**

NHM conducted a stakeholder consultation meeting on 2<sup>nd</sup> February, 2015.
