1st Corrigendum on E-Tender for selection of Agencies for Health Facility Branding in Uttar Pradesh

It is to bring to notice that the changes and corrections made in the 1st corrigendum against the RFP floated on the 18th June, 2016 named “E-Tender notice for Selection of Agency for Branding of 1093 L2 and 192 L3 Level Public Health facilities in Uttar Pradesh” are as below. This is deemed to be final from the highest authority from National Health Mission-Uttar Pradesh.

1. The Agency can submit the 2015-16 documents by its free will as an extra document but the criteria for selection of gross receipt of 8cr. will be considered as per the minimum eligibility mentioned in the RFP. Other financial conditions will remain the same as per RFP.

3. National Health Mission does not give any exemption to agency of any kind and hence there no exemptions to tender fees and EMD as mentioned in the RFP.
4. In case of any agency having turnover of Rs.10 Crore then they can follow the instructions mentioned in the DATA SHEET of the document ‘Eligibility to bid’ point number IV where it states clearly Rest of the financial Selection criteria would be multiplied by 2 in case of 2 zone bidding by Single or consortium
5. ISO 9001:2008 certified agency / consortium are also eligible to bid but it is not mandatory. For detail please refer the eligibility criteria in RFP.

5. Issue of Letter of Intent :By 29th of July 2016.
6. Signing of Agreement: Within 7 days of acceptance of the LOI.
