The entire process was done in a transparent way in presence of all Bidders and CMC members. Following decisions were taken by CMC:















1. The Total Bids received for 5 Zones were nine only. CMC Decided to open the Tenders of Facility Branding on UP E-Tender Portal and Sealed Bids received under Zone-B, Zone-D and Zone -E.
2. CMC Decided to consider the Evaluation of Technical Bids received for Zone-B, D and E.
3. The envelopes of Zone-B, D and E received in hard copies were opened by the CMC.
4. The Envelops of EMD (Bid securities) and Tender Processing Fees were opened by the Committee. CMC instructed to submit the EMD and Tender Processing Fees to Finance Division after Technical and Financial Evaluation of Bids.
5. The sealed envelopes of Financial Bids of Zone B, D and E were again sealed in Zone wise separate Envelops by the CMC.
6. The certification of Bidders were taken on completion of transparent Bid Opening process.
7. CMC decided to do the short term (7 days) E-Tender for Zone-A and Zone-C. Simultaneously CMC decided to publish the Short term Tender Notice in concerned editions of News Papers for Zone-A and Zone-C.on 29th August, 2016
8. CMC decided to deposit non refundable Tender Processing Fees of Zone A and return the EMD for Zone A to the Bidder.
