Star Rating Report Guideline for CHC



1. INTRODUCTION

Based on the available infrastructure at the health facility and the services being provided, the performance of a facility may be rated vis-à-vis other facilities. This measure is being achieved through star rating in HMIS.

For Star Rating report the following aspects are considered for a facility:

- Human Resources available
- Infrastructure available
- Drugs & Supplies
- Service Availability
- Client Orientation
- Service Utilization.

2. METHODOLOGY

This section provides the detailed methodology for generation of star rating report for CHCs and broadly covers the following:

- Data Item Details
- Criteria for Star Rating Report

2.1. Data Items

The data items to be considered for generation of star rating report for CHCs is based on the HMIS data which is reported by the facilities in infrastructure and MIS monthly format. The details of these data items are provided in the table given below:

2.2. Criteria for Star Rating Report

For each category there is a defined criterion for the award of stars to the concerned CHC as given below:

A. Mandatory Criteria

a. Human Resource

Doctors including specialists	>=2
Nurse and ANM	>=6
Lab. Technician	>=1

b. Infrastructure

Separate public utilities for males and females	Yes/No
Operation Theatre available	Yes/No
Stand by facility (generator) available	Yes/No

Note:

- If facility satisfies both criteria, facility is eligible for Star Reporting & also gets 1 Star
- If the facility fails to satisfy any of the criteria, facility is not eligible for Star Reporting with status "NE" (Not Eligible)
- If facility fails to satisfy both of the criteria((Human Resources, Infrastructure) & also do not have
 Drugs and supplies, Service availability and Client Orientation then Star Reporting is not
 applicable for facility & status of facility will be "NA" (Not Applicable) i.e. for all the items
 /parameters considered for star rating the facility has either not reported or reported '0'.
- If facility fails to satisfy both of the criteria((Human Resources, Infrastructure) & has any non-zero value for Human Resources, Infrastructure, Drugs and supplies, Service availability and Client Orientation then facility is not eligible for Star Reporting with status "NE" (Not Eligible)

B. Drugs and Supplies


