

Istitutional Del against reported dilevery is 72% whereas AHS shows 56%, Home diliveries are not reported adequately in HMIS reported only 9% to estimated



facility there is opportunity gap in pvt reporting.due to that Missing deliveries are showing high.



PW having HB level<7 is only 1% of Dist, 7 Blocks of dist reported below 1% over the period.

Hypertention cases are 5%. Meerut is not reporting good data as expected because it's consist DH.



however, some of Blocks are reported treatment of complications like IV oxytocics and IV antihypertensive not corresponding with complication.

% C-Section reported 9% other CHCs of Block are not performing C-Section. need to check data wherever C-Section has Conducted. Meerut reported 34% of c-section to total reported delivery also need to check.



Meerut - Immunisation Services Reported in HMIS during FY 2016-17 March Child Immunization trends, Distribution and progress






Gaps in Immunization :

HB0 dose are reported only 15% against estimated facility wise distribution of HB0 shows that most of HB reported from CHC & DH level facilities which is as per protocol becacuse HB0 dose should be given by facility before 24 hrs of del. Inst. delivery of dist is 20% but HB 0 16% it's seems service not given to all NB.

Measles doses are reported 61% to estimated by Dist. AHS is 71 so need to check for reporting gap. Full immunization is 62% A HS shows 57% all indicators of Dist showing very poor.
