



Women Hospital Ghazipur, and all the other units, which comes or may come during the tenure of this agreement under the present area of Medical, Health and Family Welfare Department, Ghazipur District.

And where as contractor has agreed to execute upon and subject to the conditions here to attached (here in after called and "said condition) the supplies described in general for the sum of rupees as allotted by the Department (here in after called the "contract sum")

NOW IT IS HERE BY AGREED AS FOLLOWS :

- 1 In consideration of the contract sum to be paid by the Governor at the time and in the manner set forth in the said condition and contractor will upon and subject to the said condition execute and complete the supplies and the said conditions will be binding on both the parties.

- 3 The said condition shall be read and construes as forming part of this contract and the parties here to respectively shall abide by, observe and perform and comply with the terms, stipulation and agreements there in contained and on their part to be observed performed and complied with respectively, any unilateral change in it will be void.

CONDITIONS OF CONTRACT

In these condition the following expressions have the following meaning unless the context otherwise requires viz.

"Local officer" means the officer defined and Chief Medical Officer Ghazipur or his assigns.

"C.M.O." means Chief Medical Officer for the time being in charge of the Medical, Health and family Welfare Department Ghazipur of the Government of Uttar Pradesh.


"Contractor" means the person, partners of company contently with the Employer (as herein after defined) by this indenture of which these condition form part and the pronouns, 'he' and 'his' where used in reference to the contractor shall respectively and in substitution for their ordinary meaning have the meaning of 'they' and 'their' when the contractor is a partnership or the meaning of 'it' and 'its' when the contract is a body corporate.


"Employer" means the Governor of Uttar Pradesh and his successors-in-office or assigns.

"Notice in writing" or written notice means a notice in written, typed or printed character sent (unless delivered personally or otherwise provided to have been received) by registered post to the last known private or business address or registered office of the addressee.

"This contract" means the indenture to which these condition are attached, and these condition and the details described in schedule 'B'.

- 1 For the contract sum the contractor shall make supplies of items provided by the District purchase/Tender committee at the rates approved by it in accordance with the contract.
- 2 The contractor shall start the supplies after receiving the supply order signed by authorized authority and complete them in all respect to the satisfaction of the local officer by the time period as agreed.
- 3 If the supplies are delayed by any cause outside the control of the contractor shall upon his written request to the local officer be entitled to such extension of time as requested.
- 4 If the contractor shall fail finally to complete the supplies by the specified date or within any extended time allowed under clause 3 and the local officer certified in written date the same ought reasonable so to have been completed the contractor shall pay or allow the Employer "Liquidated and contained damages" at the rate of Rupees 1/- per day for the period during which the supplies shall so remain uncompleted provided that the total amount of liquidated and ascertained damages does not exceed the sum of Rupees 200/- and the employer may deduct such damage from any money due or which may become due to the contractor no cause of delay whatever avoidable on the part of the contractor shall in any way affect the liability of the contractor under this clause.
