General Instructions for provisionally shortlisted Candidates:-

- 1. Candidate is being advised to take print out of Admit Card/submitted NHM application Form/Score Card/issued Offer letter and issued letter from NHM, UP allowing to participate in next upcoming CHO-CCHN Training Session and report at allocated Program Study Center for completing training.
- 2. Candidate is being directed to report from dated 14.11.2022 to dated 24.11.2022 to Program In-charge (Superintendent in Chief/Chief Medical Superintendent/Principal-RHFWTCs/ Medical Colleges/ Nursing College/School) at the allocated Program Study Center (PSC) with required original documents along with one set of self attested photocopy of following documents:
 - a) Copy of High School mark sheet and Pass Certificate.
 - b) Copy of Intermediate mark sheet and Pass Certificate.
 - c) Copy of mark sheet of GNM/Post Basic B.Sc Nursing/ B.Sc.Nursing Degree/Certificate from recognized Institute/ University.
 - d) Copy of valid Certificate of Registration as Nurses and Midwives from UP Nurses &Midwives Council obtained on or before dated 09.08.2022.
 - e) Copy of Category Certificate uploaded on Portal by candidate (if applicable).
 - f) Copy of ID proof, Permanent /Mailing Address proof.
 - g) Two passport size latest color photographs.
 - h) Copy of Admit Card/submitted NHM application Form/Score Card/issued Offer letter.
 - i) Applicable Surety Bond for CCHN Training on Non Judicial stamp paper of Rs. 100/.
 - j) Letter issued from NHM, UP allowing to participate in next upcoming CHO-CCHN
 - k) Medical Certificate of Health from Govt. Hospital covering the following aspects:-
 - I. General fitness.
 - II. Report of Chest X-ray.
 - III. Report of Eye Specialist on vision.
- 3. If you do not report at allocated Program Study Center on or before dated 24.11.2022, it will be presumed that you are not interested for this CCHN Training and your candidature will stand automatically cancelled.
- 4. Candidate may be allowed to join and participate in CCHN training at allocated Program Study Center from dated 14.11.2022 to 24.11.2022.
- 5. Candidate has to undergo Certificate in Community Health for Nurses (CCHN) training at the aforesaid allocated Program Study Center. During the training period, You shall be offered Rs.10,000/-(Rupees Ten Thousand) only per month as stipend as approved by Government of India. Candidate shall be entitled for stipend of training period from the date of joining at PSC and after completing Surety Bond and other formalities at the allocated program Study Center (PSC).
- 6. After successful completion of CCHN training (pass in both term end theory and practical examination separetely), you will be posted as the contractual position of Community Health Officer (CHO) at designated sub centre level Health & Wellness Center at allocated District with fixed honoraria of Rs. 20,500/-(Twenty Thousand Five Hundred) per month as per the approval of Govt. of India. You may also get an additional Rs. 15000/- (Fifteen Thousand) per month as Performance Based Incentive (PBI) as per guidelines.
- 7. Candidate who has not passed both term end theory and practical examination will be

allowed only one additional attempt in the upcoming cycle of the CCHN training and/or the candidate who does not pass in additional attempt, would not be posted as CHO.

- 8. Candidate has to sign a Surety bond of Rs. 2.50 lacs (Two Lacs Fifty Thousand) on the Non Judicial stamp paper of Rs. 100/- separately for CCHN Training at allocated Program Study Center and for serving as CHO at Sub Centers/Health & Wellness Center at allocated District for not less than three years after successful completion of CCHN training.
- 9. During the service period, you have to follow terms and conditions mentioned in Surety Bond and Service Agreement along with other guidelines issued from time to time.
- 10. You have to manage accommodation at your own expense.

- 1. Program Study Centers are being directed to initiate the **CCHN training from dated 14.11.2022** of aforesaid shortlisted candidate allocated at their Centers.
