It is to inform that time to time advertisement has been published for filling contractual position of Community Health Officer (CHO) through conducting successful CCHN Training under NHM, UP.

Kindly refer GoI letter dated 25.10.2022 (copy attached) by which following has been shared:-

"After due consideration, as proposed by the State Government, this office has no objection to pre time relaxation to CHO candidates, who joined CCH course before July-2019 batch and have already passed in 3<sup>rd</sup> attempt of CCH course conducted by IGNOU. However, this exemption shall be available to the candidates who have already passed in 3<sup>rd</sup> attempt and relate to batch till January-2021 and not later than that.

In this regard, following CCHN trainees, who have passed CCHN exam in third attempt through IGNOU shall be deputed on contractual position of Community Health Officer (CHO) at allocated District:-


