The National Health Mission (NHM), UP seeks to provide universal access to equitable, affordable and quality health care, which is accountable, yet at the same time responsive to the needs of the people, resulting in the reduction of child and maternal deaths, as well as population stabilization, gender and demographic balance. The National Health Mission (NHM), Uttar Pradesh invites online applications from eligible candidates for 5582 contractual vacancies. This is a part of initiative Under the Ayushman Bharat Scheme, GoUP envisioned to strengthen Sub-Health Centers as Health and Wellness Centers (HWCs) for improved implementation of public health programs and to enable comprehensive primary healthcare service delivery, including disease prevention and health promotion. Candidate found eligible followed by DVP and shortlisted as per NHM norms will be posted as contractual position of Community Health Officer (CHO) at Sub-Health Centers level HWCs in RURAL/VILLAGE areas on contract basis. The CHOs will work in co-ordination with primary health care team.

 Qualification: Candidates who have successfully completed B.Sc. (Nursing) with integrated curriculum of Certificate in Community Health for Nurses (CCHN) OR Post Basic B.Sc. (Nursing) course with integrated curriculum of Certificate in Community Health for Nurses (CCHN) from an Indian Nursing Council/State Nursing Council recognized Institute or University from academic year 2020 onwards shall be eligible to apply.

For clarification the academic year refer for Integration of middle level health provider (MLHP), i.e., student who have undergone 4th year B.Sc. Nursing and 2nd year Post B.Sc. Nursing in the year 2019-20 or onwards and passed the course successfully.

- 2. Age Limit as on last date of submission of online application of advertisement 21-40 Years.
- 3. Reservation Policy is applicable as per U.P. State Government rules.
- 4. **Honoraria:** Rs 20,500 (Twenty Thousand Five Hundred) per month and up to Rs 15,000 (Fifteen Thousand) per month Performance based incentive (PBI)after successful posting in the allocated district as a CHO subject to guideline issued by GoI/NHM,UP.
