Annexure- I

TERMS AND CONDITIONS OF SELECTION AS "CANDIDATE"

1. No Permanent Absorption in the NHM

- 1.1 After the joining, the candidate's will be posted as Community Health Officers (CHO) at Sub Center level Health and Wellness Centre (HWC) under District Health Society of different Districts in Uttar Pradesh.
- 1.2 The deployment of the candidate as Community Health Officer will be purely on contractual/conditional basis, and the candidate will have no right to claim for appointment on permanent roll in State Health department / State health Society/ District Health Society or permanent absorption.
- 1.3 Contractual/Conditional placement thereof to any of the Sub Centres level Health & Wellness Centre's within the State, will be at the discretion of the Management/Competent Authority.
- 1.4 Honorarium for CHO: Candidate, upon deployment as CHO, may be paid consolidated honorarium Rs. 20500/- pm and performance based incentive upto 15000/- pm for duration of his/her tenure as CHO.

2. Surety Bond

- 2.1 Candidate and his/her surety, who should be a person of substantial means, shall execute a Surety Bond (Service Bond) in the prescribed format on Rs.100/- Stamp Paper (non-judicial) to serve the District Health Society or at the discretion of the competent authority to serve any other clinic/hospital/nursing centre etc. of the State Health Department for at least three (03) years form the dated of joining.
 - Further the candidate will required to serve one month advance notice or one month honorarium in lieu of notice while on contractual/conditional employment, in addition to fulfilling the obligations stipulated in the Bond/ Rule of the District Health Society. in case the candidate serve one month advance notice or one month honorarium in lieu of notice while on contractual/conditional employment, within the Bond period i.e. three years from deployment as CHO, then he shall liable to pay without demur the entire bond amount of Rs. 2,50,000/-(Rupees Two Lakh Fifty Thousand)Only, as per the terms and conditions of the Surety Bond.
- 2.2 Candidate shall not be permitted during the Bond period to be engaged in any employment elsewhere. Candidate shall not apply for employment elsewhere during the Bond period once he/she is appointed as CHO under National Health Mission. In case he/she wants to apply for any other Job or even goes to appear to any examination/interview etc. after his appointment, then he/she needs to obtain No Objection Certificate (NOC) from the competent authority of NHM after depositing entire bond amount of Rs. 2.50 lakh. Further, if the Candidate has already applied and/or appeared in any such test or interview etc before the appointment, then the Candidate who is appointed as CHO in terms of the surety bond shall not join the new organization, unless he/she shall take NOC after depositing the entire bond amount.
- 2.3 That during the Bond period, if the candidate was found not performing as per his/her liability and responsibilities or his/her termination will be done under any unforeseen circumstances for which authority has the believe / satisfaction that were deliberately created and interrupts the smooth functioning of Health and wellness Centre, the candidate and /or the surety shall compensate DHS without demur the entire bond amount.

3. Along with the acceptance of the offer, the candidate at the time of joining, are required to bring the following documents: -

- Two passport size photographs.

In case of such evidence coming to light after candidate's joining, candidate's services (Contractual/conditional) will be liable for termination without notice at any time and Candidate will accordingly cease to be in the employment (Contractual/conditional) of the District Health Society. In such cases the candidate and /or the surety shall compensate DHS without demur the entire bond amount.
- d) The offer of selection is liable to be withdrawn at any point before joining and if joined, liable for termination without notice if competent authority comes across any evidence/ knowledge that the qualification, caste/category and/or any other particulars indicated by candidate in candidate's application/ personal resume/ other forms/ formats submitted are not recognized/ false/ misleading and/or amounts to suppression of information/ particulars / facts, which should have been brought to the notice of competent authority.
