

Type of Specialists: Anesthetist, Cardiologist, Nephrologist, Chest Physician, Gynecologist, Pediatrician and Physician

Remuneration: INR 75000 for 15 days service

Duration: 15 days continuous duration for engagement

Mode of Selection:

- District Health Society shall coordinate and conduct the process
 - Representative from Medical College shall be included in the committee
 - Where medical college is not present in the district, CMS shall be included in the committee
- Advertisement shall be published at the following places:
 - By the DHS in all the local newspapers with State email id covidpvtempanelmentup@gmail.com and CMO email id clearly mentioned for receiving applications.
 - Divisional Program Manager shall ensure they compile details from the concerned districts and publish advertisement with details of all districts of the division in the relevant newspapers under the supervision of Additional Director (AD). AD shall also write a letter to the concerned IMA office of the division informing them of the same regularly
 - SHS shall publish the advertisement in leading daily newspapers with details of the empanelment
- Any interested doctors can send their application to the email id covidpvtempanelmentup@gmail.com with cc to related District CMO Office email id.
- DHS shall compile the applications received, invite candidates meeting minimum criteria for verification of PG registration and take undertaking from the doctor in the prescribed format for empanelment to the desired facility

Terms of Engagement:

- Empaneled doctors shall be intimated at least 3 days prior to engagement.
- All specialist doctors engaged through this will be covered under the “Pradhan Mantri Garib Kalyan Package: Insurance Scheme for Health Workers Fighting Covid-19”

- PPE Kits, other protective equipment shall be provided by the facility in which the specialist doctor is engaged. Concerned CMO/govt. official shall be responsible for the same.
- Certificate of appreciation shall be awarded to the Specialists who have worked in COVID facilities under this scheme
- Accommodation and food arrangements shall be done through the CMO Office for the doctors for the duration of engagement in active quarantine
- Auxiliary staff and other equipment as per existing Govt. norms shall be available at the facility for which the Specialist doctor is engaged

Payment Terms:

- All empaneled doctors shall submit PFMS form to DAM to create their PFMS code at the time of their document verification process. DAM shall ensure that the PFMS code is created and appropriately communicated to the empaneled doctors. This code shall be used for direct payments to their bank accounts.
- Empaneled doctor shall submit invoice self-signed and duly signed by the COVID facility incharge through email to the CMO email id and covidpvtempanelmentup@gmail.com
- CMO and DAM shall ensure that the payment is released within 7 days of submission of invoice by the empaneled doctors
- FC, NHM shall track the district level payments on a monthly basis to ensure all pending invoice of more than 7 days is paid without fail
- DAM shall be held responsible for timely payment of invoices to the empaneled doctors and show cause may be issued to DAM if payments in a district are consistently delayed
- Any dispute shall be resolved by the District Health Society under which the concerned doctor is empaneled
